Consideration of Fiscal Year 2016-2017 Budget

President Farage reviewed cash on hand and the MDD line of credit with the Town. President Farage reviewed the sales tax collection and origination history. There was some discussion on the allocation of sales tax to the Lakewood Village Road Maintenance Fund. There was some discussion about how funds could be borrowed and whether it should be borrowed directly from the Town or from a bank. There was some discussion about the improvements to the water system and the minimum water repairs that where required in the previous fiscal year. President Farage reviewed the proposed budget by each line item. There was some discussion on plans to pay off the debt within one fiscal year. There was some discussion on leaving the capital improvements line item at zero for the next fiscal. President Farage reported that the MDD board makes an independent decision on the approval of the budget and the proposed numbers.

MOTION: Upon a motion made by Linda Asbell and seconded by Linda Louden, the Board voted four (4) "ayes" and one (1) "nays" (Vice President Mueller) to approve the budget as discussed. *The motion carried*.
