Consideration of Animal Control Ordinance

(Agenda Item D.4)

Councilman Wood expressed concerns with the current animal control ordinance. Councilman Wood reviewed some proposed changes to the ordinance. There was some discussion on the application of animal noise restrictions and enforcement of complaints. There was some discussion on adoption of animals picked up by animal control. Councilman Wood stated that he would prefer to see the town registration requirements removed. Councilman Getka stated he believes for public safety it is important for the town to maintain pet registration. Councilman Getka stated he prefers to see a 72 hour minimum resolution time period for correcting a complaint rather than the proposed 24 hours. There was some discussion on fine amounts and enforcement. Councilman Menckhoff asked about livestock restrictions. There was some discussion about requiring more than one complainant prior to issuing a summons for an animal owner to appear in court as a result of nuisance.

Consideration of Economic Development Corp Budget for Fiscal Year 2009-2010

Mayor Pro-Tem Vargus reported that the EDC currently has a balance of \$1,700 and is receiving approximately \$330 per month which would result in a balance of approximately \$2,700 for the year. Mayor Pro-Tem Vargus requested the EDC draft a travel policy to cover the legal training requirements. There was some discussion about the budget requirements. Mayor Pro-Tem Vargus requested the EDC pay the remaining legal fees balance by the end of next fiscal year. There was some discussion about the EDC making a budget amendment to include travel and revenue adjustment.
