Mayor Pro-Tem Vargus reported that the EDC needs additional members. Councilman Guthrie requested that Item 1 be considered separately as he was absent from that meeting.

Upon a motion made by Mayor Pro-Tem Vargus and seconded by Councilman Bushong the Council voted four (4) "ayes" and no (0) "nays" to approve consent agenda items E.2-4 as presented. *The motion carried*.

Mayor Pro-Tem Vargus expressed appreciation for the time Councilman Bushong invested in writing the ordinance and the time the rest of the council invested in the review. Mayor Pro-Tem Vargus stated that he thinks the process of review brought about good discussion and effort by the council. Councilman Guthrie reported that he reviewed the ordinance again and had a few grammatical corrections and questions. Council discussed special exceptions for building inspector error. Council discussed minimum net acreage. There was some discussion about wind energy restrictions.

Upon a motion made by Mayor Pro-Tem Vargus and seconded by Councilman Guthrie the Council voted four (4) "ayes" and no (0) "nays" to approve Zoning Ordinance 14-04. *The motion carried*.

Consideration of Subdivision Ordinance

(Agenda Item F.2)

Mayor Pro-Tem Vargus reported that Deputy Town Attorney McDonald has requested that this ordinance be tabled to allow for additional attorney review. There was some discussion regarding the different types of plats and regulation of development plats.

MOTION:

Upon a motion made by Mayor Pro-Tem Vargus and seconded by Councilman Guthrie the Council voted four (4) "ayes" and no (0) "nays" to table this item. *The motion carried.*

Consideration of Fee Ordinance

(Agenda Item F.3)

Mayor Pro-Tem Vargus reported that having a consolidated fee ordinance allows the town to simplify the process of amending fees without amending each individual ordinance. There was some discussion about the building permit fees regarding non-air conditioned space that is converted within a specific time after original construction. There was some discussion on inspections required for pre-fabricated spas. There was some discussion on the various building permit fees. There was some discussion regarding contractor registrations and the required fees. Council discussed reducing the registration fee to \$25.00. There was some discussion and review of the new tap fees. There was some discussion about platting fees.

MOTION:

Upon a motion made by Mayor Pro-Tem Vargus and seconded by Councilman Bushong the Council voted four (4) "ayes" and no (0) "nays" to approve fee ordinance 14-05 as discussed. *The motion carried*.

Mayor Pro-Tem Vargus reviewed the ordinance and the formalization of standard procedures and required controls for governmental entities. Mayor Pro-Tem Vargus reviewed the personnel section. There was some discussion on the Sunset Provision. There was some discussion on reimbursements and compensation.

MOTION:

Upon a motion made by Mayor Pro-Tem Vargus and seconded by Councilman Guthrie the Council voted four (4) "ayes" and no (0) "nays" to approve the financial controls ordinance. *The motion carried*.

Consideration of Implementation of Stage 2 Water Management Status

(Agenda Item F.5)

Mayor Pro-Tem Vargus reported on the water needs for the concrete road project and the water capacity of both the town and Rocky Point. Council discussed amending Ordinance 13-13 at the June 26th meeting to prohibit fire hydrant construction water draws except for public projects.

MOTION:

Upon a motion made by Mayor Pro-Tem Vargus and seconded by Councilman Guthrie the Council voted four (4) "ayes" and no (0) "nays" to implement stage 2 water management status until revoked by council. *The motion carried*.

Discussion of Open Records Act and Social Media

(Agenda Item F.6)

Mayor Pro-Tem Vargus reported on problems with document retention requirements being met when social media (Facebook) is used. Mayor Pro-Tem Vargus also reported on concerns with open meetings violations when discussions occur on social media. Councilman Menckhoff stated that he prefers information on Facebook be provided but no discussions take place. Mayor Pro-Tem Vargus stated that he prefers the Town Secretary be the point of contact for information provided by the town via social media. Deputy Town Attorney McDonald reported that it is a concern if a quorum of the Town Council jumped in on a Facebook conversation on a topic over which the Town Council could exercise control. Mayor Pro-Tem Vargus stated that he does not want to write a policy but he prefers a "gentleman's agreement" that council not post city business on social media. Deputy Town Attorney clarified that posting anything about town business on social media, whether on a group page, or personal page would be subject to open records requests.
