Linda Louden volunteered to coordinate the event. Linda Louden will attend the council meeting in March to request council/town support.

President Farage discussed paying down on the line-of-credit balance owed to the Utility Fund and paying off the bill for legal services. President Farage proposed paying the attorney bill in full from the MDD General Fund. There was some discussion about the balance of funds after the legal fee was paid. There was some discussion about keeping a balance of \$2,700 to cover deposits held on water accounts.

- MOTION: Upon a motion made by Linda Louden and seconded by Dave Batchelder, the Board voted five (5) "ayes" and no (0) "nays" to make a \$6,466.77 payment to the balance owed to the Lakewood Village Utility Fund before the end of the month. *The motion carried.*
- MOTION: Upon a motion made by Linda Louden and seconded by Bernd Mueller, the Board voted five (5) "ayes" and no (0) "nays" to amend the budget to transfer \$3,906.70 from the Projects budget line to the Legal Services budget line.. *The motion carried.*
- MOTION: Upon a motion made by Linda Louden and seconded by Bernd Mueller, the Board voted five (5) "ayes" and no (0) "nays" to make a \$3,906.70 payment to the Lakewood Village General Fund to reimburse legal fees before the end of the month. *The motion carried*.
